# PETITION TO SET ASIDE THE NOMINATION PAPER OF JEFFREY LEE BARKER AS A KEYSTONE CANDIDATE FOR REPRESENTATIVE IN THE GENERAL ASSEMBLY FOR THE 43rd LEGISLATIVE DISTRICT

### PARTIES AND JURISDICTION

1. This Honorable Court has jurisdiction of this matter pursuant to 25 Pa.C.S. §2937 and 42 Pa.C.S. §764.

2. Petitioner Kevin L. Hostetter is a qualified elector registered to vote in the 43rd Legislative District, residing at 219 Raspberry Road, Leola, Pennsylvania.

3. Petitioner Robert D. Winegardner is a qualified elector registered to vote in the 43rd Legislative District, residing at 254 Orchid Court, New Holland, Pennsylvania.

4. As the Petitioners are qualified electors residing and registered to vote in the 43rd Legislative District, they have standing to file this petition.

5. On or about August 1, 2022, Jeffrey Lee Barker, (hereinafter "the Candidate") filed a nomination paper to appear on the ballot as a Keystone candidate for Representative in the General Assembly in the 43rd Legislative District.

### FACTUAL BACKGROUND

6. A Keystone candidate for Representative in the General Assembly must file a nomination paper containing at least 300 valid signatures from qualified electors residing and registered to vote in the district that they seek to represent, in this case the 43rd Legislative District. (A copy of the Department of State's calculation of the number of signatures required for minor party or political body candidates to qualify to appear on the ballot is attached hereto and incorporated herein by reference, marked as Exhibit A)

7. The nomination paper filed by the Candidate consists of 23 numbered pages. (A copy of said nomination paper is attached hereto and incorporated herein by reference, marked as Exhibit B)

8. The Commonwealth of Pennsylvania's official form for nomination papers contains two sides to each page and has spaces for 50 signatures.

9. The nomination paper filed by the Candidate had a total of 667 lines filled in with at least some writing on them.

10. The Petitioners and their representatives have reviewed the Candidate's nomination paper and based upon that review believe and aver that the nomination paper is defective and does not contain a sufficient number of genuine signatures of qualified electors residing and registered to vote in the 43rd Legislative District and therefore fails to comply with the Election Code.

11. The Petitioners have used the spreadsheet form required by this Court which will be submitted in digital format and a copy of which is attached to this petition which states the 631 lines that are challenged, which would leave the Candidate with only 36 valid signatures, which is less than the 300 valid signatures required and is therefore insufficient for the Candidate to be placed on the ballot in the general election. (A copy of said spreadsheet is attached hereto and incorporated herein by reference, marked as Exhibit C. The version of the spreadsheet submitted in digital format is also incorporated herein by reference.)

12. The Candidate submitted said nomination paper with the knowledge that said nomination paper was defective or with reckless disregard of whether it was defective and should be required to pay the Petitioner's attorney's fees and costs.

WHEREFORE, the Petitioners, Kevin L. Hostetter and Robert D. Winegardner, respectfully request that this Honorable Court:

a) set aside the nomination paper filed by Jeffrey Lee Barker;

b) direct that the Secretary of the Commonwealth not certify Jeffrey Lee Barker as a
 Keystone candidate for the general election for Representative in the General Assembly for the 43rd
 Legislative District; and

c) order Jeffrey Lee Barker to pay the attorney's fees and costs of the Petitioner.
