ORDER

AND NOW, this ______ day of ______, 2022, upon consideration of the Petition to Set Aside the Nomination Papers of Joel Getz, III, as Libertarian Candidate for State Senator from the 40th Senatorial District in the General Election of November 8, 2022 ("Objection Petition"); it is hereby ORDERED as follows:

1. Joel Getz, III ("Respondent") does not have the requisite number of genuine signatures of electors as required under the Pennsylvania Election Code to have his name placed on the November 8, 2022 General Election ballot as a Libertarian Candidate for State Senate from the 40th Senatorial District.

2. Petitioners' Objection Petition is GRANTED: Petitioners' objections to the Respondent's Nomination Papers are SUSTAINED, all invalid signatures therein are STRICKEN, and Respondent's Nomination Papers are SET ASIDE.

3. The Secretary of the Commonwealth of Pennsylvania is to strike and set aside Respondent's Nomination Papers and is hereby further directed to remove the name of Joel Getz, III, from the November 8, 2022 General Election ballot for Libertarian candidate for State Senate from the 40th Senatorial District.

4. Respondent and/or his official Campaign and/or Campaign Committee are to make payment for the costs of these proceedings, including witness fees and such other reasonable costs and attorneys' fees, in the amount of \$_____, incurred by the Petitioners in bringing forth this Objection Petition.

PETITION TO SET ASIDE NOMINATION PAPERS OF JOEL D. GETZ, III, AS LIBERTARIAN CANDIDATE FOR STATE SENATE FROM THE 40TH SENATORIAL DISTRICT IN THE NOVEMBER 8, 2022 GENERAL ELECTION

TO: THE HONORABLE JUDGES OF THE COMMONWEALTH COURT OF PENNSYLVANIA

AND NOW, this 8th day of August, 2022, come Petitioners, John A. Casella and Frank C. Revitt (collectively, "Petitioners" or "Objectors"), by and through their attorneys, Avolio Law Group, LLC, and file this Petition to Set Aside the Nomination Papers of Joel D. Getz, III, as Libertarian Candidate for State Senator from the 40th Senatorial District in the General Election of November 8, 2022 ("Objection Petition"), and in support thereof, respectively represent as follows:

PARTIES, STANDING AND JURISDICTION

Petitioner, John A. Casella, has a primary address at 1530 Gardner
 Road, Stroudsburg, PA 18360, is an adult individual, citizen, and registered,
 qualified voter in the 40th Senatorial District of the Commonwealth of Pennsylvania.

2. Petitioner, Frank C. Revitt, has a primary address at 2214 St. Andrews Lane, Stroudsburg, Pa. 18360, is adult individual, citizen, and registered, qualified voter in the 40th Senatorial District of the Commonwealth of Pennsylvania.

3. Respondent, Joel D. Getz, III ("Respondent"), on or about August 1, 2022, filed Libertarian Nomination Papers ("Papers") seeking a ballot position in the 2022 General Election to vie for election as Senator in the General Assembly from the 40th Senatorial District. A copy of the Papers is attached hereto and marked as Exhibit "A".

4. The Libertarian Party is a minor political party as defined by 25 P.S. §2831(a) and (b) and whose candidate nominations are governed by § 2872.2.

5. Objections to a minor party candidate's nomination papers may be filed by any person who is registered to vote and may vote for such candidate in a particular election. <u>In re Barlip</u>, 428 A.2d 1058, 1060 (Pa. Cmwlth. 1981).

6. The Commonwealth Court of Pennsylvania has exclusive original jurisdiction over objections to the nomination papers of a minor party candidate for statewide office pursuant 42 P.S. § 764 and 25 P.S. § 2937, which governs the

procedures for such objections. <u>In re Vidmer</u>, 442 A.2d 1203, 1204, <u>aff'd</u>, 497 Pa. 642, 444 A.2d 100 (Pa. Cmwlth. 1982).

FACTUAL BACKGROUND

7. Respondent filed nomination papers on or about August 1, 2022, seeking the nomination of the Libertarian Party to the office of Senator in the General Assembly from the 40th Senatorial District.

8. To appear as a senatorial candidate on the 2022 General Election ballot, Respondent must present at least 516 valid signatures from registered Pennsylvania voters of the 40th Senatorial District by the filing deadline of August 1, 2022. *See* 25 P.S. §§ 2872.2 and 2911(b).

9. Respondent's Papers contain 654 signatures on 29 pages, the original Nomination Papers and Candidate's Affidavits remain in the custody of the Secretary of the Commonwealth and are incorporated herein by reference and are included as Exhibit A.

RESPONDENT DID NOT SUBMIT 516 VALID SIGNATURES ON HIS NOMINATING PAPERS, AND MUST BE REMOVED FROM THE BALLOT

10. Section 2872.2 of the Pennsylvania Election Code, 25 P.S. § 2601 *et seq.*, governs nominations by minor political parties and incorporates the requirements set forth in § 2911(b) for each signer of a nomination paper. As applied to Respondent's Papers, § 2911(b) requires that each signer must:

- a. "declare therein that he is a qualified elector of the . . . district";
- b. "add to his signature his legibly printed name and residence, giving city, borough or township, with street and number, if any, and shall also add the date of signing, expressed in words or numbers";
- c. sign but "one nomination paper for each office to be filled."

Having thoroughly reviewed the Papers, attached hereto as Exhibit A,
 Objectors assert that Respondent has failed to meet the requirement of presenting
 516 valid signatures of qualified Pennsylvania electors of the 40th Senatorial District.

12. While Respondent submitted 654 signatures, only 436 of those 654 signatures meet the legal requirements to be counted towards the 516 signatures required by statute for Respondent to have his name placed on the ballot.

13. 218 of the signatures Respondent collected are defective in at least one way, and often in multiple ways.

14. Section 2937 of the Pennsylvania Election Code provides that the Court shall set aside nomination papers that are defective.

15. Exhibit B to this Objection Petition is a spreadsheet prepared pursuant to this Court's July 29, 2022 Order in <u>In re: Objections to Nomination Papers of</u> <u>State Level Minor Political Party Candidates and Independent Candidates of</u> <u>Political Bodies - General Election 2022</u> (Pa. Cmwlth., No.126 Misc. Docket No. 3), listing by line and number the specific signatures objected to, applying the following challenge codes, a key of which is attached separately as Exhibit C:

NR = Not Registered NRA = Not Registered at Address NRD = Not Registered in District NRDS = Not Registered on Date Signed OC = Out of County Ill = Illegible LIO = Line Information Omitted DUP = Duplicate IHA = Line Information in Hand of Another N/I = Nickname/Initial PRI = Printed Signature Other = Any ground for objection not listed above

Indisputably Defective Signatures

16. Many of the signatures gathered are defective on grounds that are easily assessed by the Court, being either facially defective or which can be confirmed through verification with the Commonwealth's SURE system. These signatures fall into one or more of the following categories:

17. **Signer Not Registered**. Upon information and belief, the 43 signatures in Exhibit B with code NR represent signers who are not registered to vote and who thus are not qualified to sign the Papers pursuant to 25 P.S. § 2911(c), and whose signatures must therefore be stricken as invalid.

18. Signer Not Registered at Address. Upon information and belief, the60 signatures in Exhibit B with code NRA represent signers who are not registered

to vote at the address provided in the Papers as required by § 2911(c), and whose signatures must therefore be stricken as invalid.

19. **Signer Not Registered in District**. Upon information and belief, the 156 signatures in Exhibit B with code NRD represent signers who are not registered to vote in the 40th Senatorial District and who thus are not qualified to sign the Papers pursuant to 25 P.S. § 2911(c), and whose signatures must therefore be stricken as invalid.

20. **Signer Not Registered on Date Signed**. Upon information and belief, the 54 signatures in Exhibit B with code NRDS represent signers who were not registered to vote on the date they signed the Papers and who thus are not qualified to sign the Papers pursuant to 25 P.S. § 2911(c), and whose signatures must therefore be stricken as invalid.

21. **Out of County**. Upon information and belief, the 13 signatures in Exhibit B with code OC represent signers who do not reside in the county named in the Papers as required by 25 P.S. § 2911, and whose signatures must therefore be stricken as invalid.

22. **Signature Line Information Omitted**. Upon information and belief, the 28 signatures in Exhibit B with code LIO represent signers whose signature line is missing some data required by § 2911(c), and whose signatures must therefore be stricken as invalid.

23. In all, **189** signatures must be stricken as indisputably defective for being either facially defective or confirmed defective through verification with the Commonwealth's SURE system, which leaves only **465** remaining signatures of the 654 submitted by Respondent.

Additionally Defective Signatures

24. A further number of signatures gathered by Respondent reflect additional errors based on Petitioners' review but which will require further testimony or the judgment of the Court in order to confirm the invalidity of these lines.

25. **Illegible Information**. Upon information and belief, the 29 signatures in Exhibit B with code ILL represent signers whose information was not written in a way such that it could be verified, including illegible signatures, as required by 25 P.S. § 2911, and whose signatures must therefore be stricken as invalid.

26. **Information in the Hand of Another**. Upon information and belief, the 12 signatures in Exhibit B with code IHA represent purported signers whose signature lines contain at least some information which appears to have been provided by someone other than the signer, contrary to the dictates of 25 P.S. § 2911, which requires that the signatures be stricken as invalid.

27. **Printed Signature**. Upon information and belief, the 2 signatures in Exhibit B with code PRI represents a signer who printed his name instead of signing

it, which requires that the purported signatures be stricken as invalid pursuant to 25 P.S. § 2911.

28. **Other**: Upon information and belief, the 5 signatures in Exhibit B with code Other represent signers whose signatures are invalid for the reasons set forth therein, which requires that the signatures be stricken as invalid pursuant to 25 P.S. § 2911.

29. In all, 29 signatures upon Petitioners' review contain additional errors requiring further testimony and this Court's review to determine if they must also be stricken as defective.

CONCLUSION

30. In all, Petitioners assert that **218** signatures must be stricken as invalid on all of the aforementioned bases, with **189** of those signatures being indisputably defective.

31. Having presented only **436** valid signatures, and needing 516, Respondent has not qualified under the terms of the Pennsylvania Election Code to appear as a candidate for the Libertarian Nomination for State Senate from the 40th Senatorial District in the General Election of November 8, 2022.

32. Petitioners are prepared to substantiate these objections via testimony and evidence presented at a prompt hearing and respectfully reserve the right to add such additional objections as are appropriate at the time of said hearing. as mandated by 25 P.S. § 2937;

RELIEF

WHEREFORE, Petitioners, John A. Casella and Frank C. Revitt, humbly pray and request that this Honorable Court enter an Order:

1) Scheduling a hearing on Petitioners' Objection Petition no later than ten (10) days after August 8, 2022 pursuant to 25 P.S. § 2937;

2) Declaring that Joel D. Getz, III, does not have the requisite number of genuine signatures of electors as required under the Pennsylvania Election Code to have his name placed on the November 8, 2022 General Election ballot as a Libertarian Candidate for State Senate from the 40th Senatorial District;

Sustaining Petitioners' objections to Respondent's Nomination
 Papers, striking all invalid signatures therein, and setting aside Respondent's
 Papers in accordance with the Pennsylvania Election Code;

4) Directing the appropriate officers of the Commonwealth of Pennsylvania to strike and set aside the Nomination Papers of Joel D. Getz, III, and further directing them not to place his name on the ballot for the November 8, 2022 General Election for the office of State Senator of the 40th Senatorial District; and 5) Granting such other and further relief, including payment of the costs of the proceedings and witness fees, as this Court deems necessary and just. 25 P.S. § 2937.




