COMMONWEALTH'S MOTION TO REVOKE BAIL

AND NOW, this 18th day of August 2023, the Commonwealth of Pennsylvania, by and through its attorney, Zachary Yurick, Assistant District Attorney, files this Motion to revoke/increase bail. In support thereof, the Commonwealth avers the following:

1. On April 23, 2023, the Pennsylvania Police filed charges against the Defendant. These charges include Terroristic Threats and Simple Assault. Bail was set by the Magisterial District Court on this case at \$50,000 unsecured.
2. The Defendant was ordered to undergo a drug and alcohol evaluation. He never provided proof. He was also ordered to conduct weekly phone check ins. He failed to call in every week.
3. On July 27, 2023, the charges were held over for court. The Defendant's bail conditions were changed to randomized drug testing, report to Recovery Centers of America, and comply with their recommendations.
4. On August 7, 2023, West Goshen Police made contact with the Defendant outside a Wawa. Officers believed the Defendant to be intoxicated and saw him drinking alcoholic beverages. They assisted him back to a hotel. No charges were filed.
5. Two days later, on August 9, 2023, Radnor police cited the Defendant with public intoxication and disorderly conduct. The Defendant's BAC was .18 and he admitted to kicking a car windshield so hard it cracked.

6. Due to the Defendant incurring new charges that demonstrate the Defendant's need for drug and alcohol treatment, the Commonwealth is requesting this Court revoke the Defendant's bail until he is assessed by our pretrial services and sent by sheriff transport to inpatient treatment.


