AMENDED PETITION FOR RECOUNT AND RECANVASS <u>TO CORRECT EXHIBIT 1</u>

Pursuant to Sections 1701(a.1), 1702(a)(2), and 1703(a) of the Pennsylvania Election Code, 25 P.S. §§ 3261(a.1), 3262(a)(2) and 3263(a), Petitioners, by their undersigned counsel, hereby submit this Amended Petition, in order correct and replace Exhibit 1 to Petitioners' May 31, 2022 Petition, seeking (a) the opening and recount by hand of the ballot boxes and their paper ballots, including all absentee and mail-in ballots (whether domestic, overseas, or military), and provisional and emergency ballots, (b) the recanvass of voting machines, and (c) the recount and recanvassing of the votes cast on such ballots and machines in the counties and election districts identified in Corrected Exhibit 1 attached hereto, as they relate to the election of the Republican nominee for the Office of U.S. Senate in the May 17, 2022 General Primary. In support thereof, Petitioners aver as follows: 1. On May 17, 2022, a General Primary was held in Pennsylvania, in which candidates for all offices to be filled at the November 8, 2022 General Election shall be nominated by the Pennsylvania Republican Party ("May 17, 2022 Primary"). *See* Section 603 of the Pennsylvania Election Code, 25 P.S. § 2753.

2. One of the offices for which a nominee of the Pennsylvania Republican Party is to be elected during the May 17, 2022 Primary is the United States Senate.

3. There were eight candidates on the May 17, 2022 Primary ballot for the United States Senate Republican nominee.

4. The unofficial results of said election show the top two candidates to be David H. McCormick, with 418,463 votes, and Dr. Mehmet C. Oz, with 419,365 votes.

5. Pursuant to Section 1404(g)(1)(i) of the Pennsylvania Election Code, 25 P.S. § 3154(g)(1)(i), the Acting Secretary of State for the Commonwealth issued on May 26, 2022, an Order of Recount for the Republican Primary for United States Senator, attached as Exhibit 3, and a Declaration Regarding Unofficial Returns for the General Primary Held May 17, 2022, attached as Exhibit 4.

6. It is submitted that the closeness of the results of the race among the top two candidates for the United States Senate Republican nominee requires the

recounting of the ballots and the recanvassing of the voting machines in said race in the election districts identified in Exhibit 1, as there exists the possibility of human or mechanical error in the counting and tabulation of the votes casted in that race, including but not limited to, errors related to ballots containing undervotes or overvotes.

7. Petitioners believe, based on information they consider reliable, that fraud or error, although not manifest on the general return of votes was committed in the computation of votes cast, in the marking of the ballots, in the canvassing of the votes cast on the machines, or otherwise in connection with the ballots or casted votes in the election districts identified in Exhibit 1 as they relate to the race for the United States Senate Republican nominee.

8. Petitioners are prepared to file an appropriate cash deposit or bond as this Court may order. However, there is a conflict under Sections 1701(a.1), 1702(a)(2), and 1703(a) of the Pennsylvania Election Code, 25 P.S. §§ 3261(a.1), 3262(a)(2) and 3263(a), as to whether any such security is required in cases where a recount and recanvass has been ordered by the Secretary of the Commonwealth under Section 1404(g) of the Election Code, 25 P.S. § 25 P.S. § 3154(g), and if security is required, what the amount of that security should be and where that security must be filed.

9. Sections 1701(a.1) and 1702(a)(2) of the Pennsylvania Election Code, 25 P.S. §§ 3261(a.1) and 3262(a)(2), do not contain any requirement for the filing of a security where a recount or recanvass petition has been filed in cases resulting from a Secretary's recount or recanvass order under Section 1404(g) of the Election Code, 25 P.S. § 25 P.S. § 3154(g). Instead, all that Election Code Sections 1701(a.1) and 1702(a)(2) require is the filing in this Court of a verified petition for recount and/or recanvass brought by at least three (3) qualified electors of each county in which a recount and/or recanvass is sought. 25 P.S. §§ 3261(a.1), 3262(a)(2).

10. Further, although Sections 1701(b) and 1702(a.1) of the Pennsylvania Election Code, 25 P.S. §§ 3261(b) and 3262(a.1) explain the general requirements for a cash deposit in the amount of fifty dollars (\$50.00) per ballot box or voting machine per precinct or a court-approved corporate surety bond in the amount of one hundred dollars (\$100.00) per ballot box or voting machine per precinct, and along with Section 1703 of the Election Code, 25 P.S. § 3263(a)(1)(i)(B), provide that the security must "accompany[y]" the recount and recanvass petition, all of these Election Code Sections refer to the filing of the recount and recanvass petitions "in the office of the prothonotary of the proper county," rather than in this Court as mandated by Sections 1701(a.1) and 1702(a)(2) of the Pennsylvania Election Code, 25 P.S. §§ 3261(a.1) and 3262(a)(2). Therefore, under Sections

1701(a.1) and 1702(a)(2) of the Pennsylvania Election Code, 25 P.S. §§ 3261(a.1) and 3262(a)(2), there does not appear to be any requirement for the posting of security when the recount and recanvass petition is filed in cases resulting from a Secretary-ordered recount or recanvass.

11. To the extent that Sections 1701(b) and 1702(a.1) of the Pennsylvania Election Code, 25 P.S. §§ 3261(b) and 3262(a.1) apply, and based on the ballot boxes and voting machines sought to be recounted and recanvassed, if this Court were to rule that security is required, then each county group of Petitioners are prepared to post the following security (cash or bond) for their respective county election districts sought to be recounted and/or recanvassed:

A proposed order is attached.

AND, NOW, to-wit, this _____ day of _____, 20___, upon consideration of Petitioners' Petition for Recount and Recanvass, and finding that all the requirements for such petition as set forth in Sections 1701(a.1), 1702(a)(2), and 1703(a) of the Pennsylvania Election Code, 25 P.S. §§ 3261(a.1), 3262(a)(2) and 3263(a), have been met, it is hereby ORDERED, ADJUDGED and DECREED that said Petition is <u>GRANTED</u>.

It is further ORDERED that all ballots cast in the counties and election districts identified in Exhibit 1 attached to the Petition (whether those ballots have been cast by paper, absentee, mail-in, overseas, military, emergency, provisional, electronically, or other means) as they relate to the election of the Republican nominee for the Office of U.S. Senate in the May 17, 2022 General Primary, shall be opened and recounted by hand, and all voting machines in the same counties and election districts shall be recanvassed for the same election, by no later than this ____ day of _____, 2022, at ____.m., at locations designated by each of the counties involved.

The Boards of Elections in each of the affected Counties are hereby directed to provide notice, either personally or by registered mail, of the ordered recounting and recanvassing to Candidates David H. McCormick and Dr. Mehmet C. Oz, or their committees, no later than forty-eight (48) hours before the recounting and recanvassing are scheduled to occur.

Within three (3) days from the date of this Order, each county group of Petitioners shall post with the Prothonotary of this Court the following security (cash or bond) for the respective election districts sought to be recounted and/or recanvassed:

Similarly, to the extent any county group of Petitioners files a corporate surety bond, it shall be signed by the respective Petitioners as principals and by a corporate surety approved by this Court, and conditioned upon the payment to the county treasurers for the use of the counties of the sum of fifty dollars (\$50.00) per precinct of ballot boxes opened or voting machines canvassed, in the event that upon the opening of the ballot boxes or the recanvass of the voting machines, it does not appear that fraud or substantial error was committed in the vote computation, ballot marking, machine canvassing, and otherwise in connection with such ballots or voting machines.

### ORDER OF RECOUNT FOR THE REPUBLICAN PRIMARY FOR UNITED STATES SENATOR

Based on the unofficial returns for the General Primary held May 17, 2022 that have been submitted to the Department of State by the 67 county boards of elections pursuant to Section 1404(f) of the Pennsylvania Election Code (25 P.S. § 3154(f)), it appears that a candidate in the Republican Primary for the office of United States Senator was defeated by one-half of a percent or less of the votes cast for the office, and the defeated candidate did not request that a recount not be made under Section 1404(h) of the Election Code (25 P.S. § 3154(h)).

Therefore, in accordance with Section 1404(g)(1) of the Election Code (25 P.S. § 3154(g)(1)), I hereby ORDER a statewide recount of the entire vote cast in the **Republican Primary for the office of United States Senator** to be conducted by the county boards of elections. The recount may begin as early as Friday, May 27, 2022, but must commence no later than **June 1**, 2022, and be completed by **Noon on Tuesday**, **June 7**, 2022. The county boards of elections must submit the results of the recount no later than **Noon on Wednesday**, **June 8**, 2022. See 25 P.S. § 3154(g)(5)(ii), (iii) and (6).

The county boards of elections must follow the procedures outlined in Section 1404(e) and (g) of the Election Code, the Statewide Return and Recount Directive and Procedures, and any supplemental procedures provided by the Secretary of the Commonwealth and must report the recount numbers on the Recount Tabulation Form. 25 P.S. § 3154(e) and (g). In accordance with Section 1404(e) of the Election Code, the county boards of elections must "give notice in writing to the proper custodian of voting machines, and to each candidate, and to the county chairman of each party or political body, affected by the recount or recanvass; and each such candidate may be present in person, or by attorney, and each of such parties, or bodies, may send two representatives to be present at such recount or recanvass." 25 P.S. § 3154(e).

Based on the unofficial returns submitted under Section 1404(f) of the Election Code, I have determined that no candidate was defeated by one-half of one percent or less of the votes cast for the following offices:

Democratic Primary for United States Senator Democratic Primary for Governor Republican Primary for Governor Democratic Primary for Lieutenant Governor Republican Primary for Lieutenant Governor

Consequently, under Section 1404(g) of the Pennsylvania Election Code I have no cause to order a recount of the election returns in the 67 counties for those offices.

Further, based on the unofficial returns submitted under Section 1404(f) of the Election Code, as to the **Republican Primary for United States Senator**, I have determined that one candidate was defeated by one-half of a percent or less for the office. Therefore, in accordance with Section 1404(g)(1) of the Election Code (25 P.S. § 3154(g)(1)), I have separately ordered a statewide recount of the entire vote cast for the **Republican Primary for United States Senator** to be conducted by the county boards of elections.
