AND NOW, this 3<sup>rd</sup> day of January, 2023, after hearing and BRYAN KOHBERGER's voluntary waiver of his rights pertaining to extradition, it is hereby **ORDERED** that the Defendant, BRYAN KOHBERGER, in the custody of the Sheriff of Monroe County, Pennsylvania, be by him surrendered to the Latah County District Attorney's Office, State of Idaho, or its authorized representatives within ten (10) calendar days of this date.

**IT IS FURTHER ORDERED** that, the Defendant having signed in Our presence a writing which states that he consents to return to the demanding state of Idaho, said writing shall be forwarded by the Clerk of Courts to the office of the Governor of this Commonwealth.

The Sheriff of Monroe County, Pennsylvania is **ORDERED** to deliver a copy of the Defendant's signed written consent to the duly accredited agents of the demanding state of Idaho.




