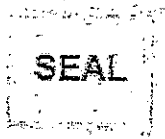

AFFIDAVIT of PROBABLE CAUSE

Your affiant is Detective Lawrence Minnick of the Lebanon City Police Department, 400 S 5th St. Lebanon, PA 17042. Det. Minnick has been a police officer for 26 years. I have been assigned to the Detective Division for 10 years.

On May 30, 2023, Lebanon City Police were dispatched to 444 N 5th St. Lebanon, PA for a report of gunshots fired. Upon arriving Lebanon City Police units observed multiple gunshot victims to the rear of 444 N 5th St. Three victims & an 8 year old juvenile with initials JP, a 9 year old with initials SP, and a 19-year-old named Joshua Lugo Perez had been on the rear porch of the 444 N 5th St. at the time of the shooting. They were struck by gun fire. All three subsequently died from their gunshot wounds. A 33-year-old occupant of 445 N 5th St, Luis Cancel was also struck by gunfire while inside the residence. He was transported the hospital for injuries that required emergency medical treatment.

As the investigation continued, three suspects were developed as being responsible for the homicides. These three individuals were identified as Alex Torres-Santos, James Fernandez-Royas and Ivan Claudio Rosero.

On June 3, 2023, members of the Lebanon County SWAT team and the Lebanon City Police Department executed a search warrant at 34 Cumberland Street. Residents of 34 Cumberland Street were identified as Tiffany Koziara and Ivan Claudio Rosero. During an interview with Koziara, she identified her boyfriend and father of her son as Rosero. Koziaras stated that she owns a white 2013 BMW SUV, a black 2019 Mercedes Benz sedan and a black 2014 Nissan Maxima. At the time of the execution of search warrant, the white BMW was not on scene.

Koziara was later interviewed regarding her knowledge of Rosero's whereabouts and her communication with him. Koziara stated that she has not talked to him since Wednesday. Koziara stated that she has sent him text messages related to him cheating on her but she has received no response. When asked about her knowledge of



Rosero's whereabouts or his involvement in this investigation, she said that they have not spoken about it outside of her reference to news coverage. She reiterated that she has no idea where he could be or where he is going.

As a result of the search warrant executed at 31 Cumberland Street, Koziaras cellular telephone was seized and analyzed. Several items of media and messaging were located on her device. These items included text messaging with Rosero on WhatsApp. Also located on her phone were travel arrangements she had made for Rosero including booking him a hotel in the Atlantic City area on 06-04-2023. This booking was completed before my conversation occurred with Koziara.
