JOINT APPLICATION FOR APPROVAL OF SCHEDULING ORDER

The League of Women Voters of Pennsylvania and Lorraine Haw (“the League”) and Intervenor Ronald Greenblatt (together, “Petitioners”) and Kathy Boockvar, Secretary of the Commonwealth (“Secretary”) and Intervenors Martin Vickless, Kelly Williams, Shameekah Moore and Kristin June Irwin (together, “Respondents”) (collectively, the “Parties”), hereby submit this Joint Application for Approval of Scheduling Order, as follows.

1. The Parties have conferred in good faith to agree upon a schedule for the filing of applications for summary relief to bring this case to final resolution.
2. The Parties have agreed that they will respectively file applications for summary relief and supporting briefs on December 13, 2019.
3. Thereafter, opposition briefs will be filed on January 10, 2020.
4. Finally, reply briefs will be filed on January 24, 2020.

5. The Parties respectfully request that this Honorable Court enter an Order approving and adopting the filing and briefing schedule, as outlined above.
